2. The candidature of all the candidates short listed for verification is purely provisional subject to fulfilment of eligibility criteria with regard to age, essential qualification and reservation etc.
3. The candidates must ensure that they belong the respective category/sub category as mentioned in the above list.
4. Candidates belonging to other categories/sub-categories are required to submit the requisite certificates in the prescribed proforma given in the Annexure-A to Annexure-G of the detailed advertisement.
5. Candidates seeking age relaxation as Government Employee/ESIC Employee shall have to produce Service Certificate.
6. In the detailed advertisement for the post of UDC, MTS & Steno, it has been notified that the facility of scribe shall be given only to persons with benchmark disabilities in the category of **blindness, locomotor disability (both arm affected-BA) and cerebral palsy**, if so desired by the person. For other category of persons with benchmark disabilities, the provision of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government health care institution as per prescribed proforma appended at Annexure - G of the advertisement. As such, PWD candidates other than in the category of **blindness, locomotor disability (both arm affected-BA) and cerebral palsy**, who have availed services of scribe in the Phase I and/or Phase II Exam for the post of UDC are required to submit certificate regarding physical limitation to write in the prescribed proforma appended at Annexure - G of the advertisement.
